Please be informed that in the event of a vehicle accident, D&D Driving School has liability insurance for all vehicles used for lessons. Students will be covered under the Driving School's PIP coverage. By signing this document, you, the student or parent if under the age of 18 withhold all rights to have any intent to sue D&D Driving School or the Instructor.

Any damage brought on by the student to the vehicle, he/she or parent will be responsible for paying half of the cost of the amount it takes to repair, if he/she or parent choose not to file a claim with their insurance. Should the student require medical attention, he/she will be covered under our PIP. If another vehicle is involved, you have the option of paying half of what the cost of repairs is less than our deductible (\$1000). We give you the student the option because accidents can stay on your driving record for up to 7 years and increase car insurance.

If the student and/or parent chooses to file a claim with D&D Driving School commercial insurance, the student or parent is responsible for half the deductible of \$1000 (\$500).

Please keep in mind, there are risks taking while training a student and there are unforeseen events. Please make sure you have all parties on your car insurance before placing them behind the wheel of a car.
